Note 1:

Public Holidays on account of Fateha-Duaz-Daham(January 4th), Sreepanchami(January 25th) fall on Sundays. Executive Holiday on account of Rabindranath's Birthday (May 9th) falls on Second Saturday. Public Holiday on account of Republic Day (January 26th) coincides with the public holiday on account of Sreepanchami. Public Holiday on account of Birthday of Dr. B.R. Ambedkar (April 14th) coincides with the traditional Court Holiday on account of Chaitra Sankranti.

Note 2:

If any of the Muslim Festivals notified above does not fall on the day notified, Muslim officials and employees of City Civil Court, Calcutta may be granted holiday on the day on which the festival is actually observed in addition to the holiday on the day notified.

Note 3:


Sectional holidays on account of Buddha Purnima (May 4th), Mahabir Jayanti (April 2nd) and Sabe Barat (5th June) may be granted, when possible to Buddhist, Jain and Muslim employees respectively. Sectional holiday on account of Baisakhi (April 14th) coincides with Public holiday on account of Birth day of Dr. B.R. Ambedkar and traditional Court holiday on account of Chitra Sankranti. All officials, Suitors and Witnesses who profess the Brahma faith may be granted, when possible 3(three) days' holidays on account of Maghotsav one day before and one day after that date.

Note 4:

Chief Judge, City Civil Court, Calcutta may be empowered to declare local holidays not exceeding 2(two) days in a year according to prevalent customs in consultation with the local Bar Association.

Note 5:

All 2nd and 4th Saturdays of months have been declared as holidays for the Courts Subordinate to the High Court in West Bengal vide F.C. Resolution dated 06.08.1992.
