In compliance with the solemn direction of the Hon'ble Committee for West Bengal Judicial Academy, three (03) Judicial Officers in the rank of District Judge (Entry Level), Batch, 2022, details whereof are annexed herewith, have been included in the list of Trainees for Induction Training [P-75/2024-25, Batch-2023] of newly promoted ADJs which is to be held on and from 11.11.2024 to 26.11.2024 .

The male Officers should be dressed in black Coat and Tie and female Officers should have black Coats, which are mandatory. The Officers should carry their official laptops.

You are also requested to make necessary administrative arrangements in absence of the nominated Officer(s) from the station.
