It is brought to the notice of Hon'ble Judges of the High Court that Judicial Officers are not proceeding with the trial of the case only because of pendency of Appeal/Revision in connection with the said case before the Hon'ble High Court, even when no stay order has been granted by the Hon'ble Court.

I am directed by the Hon'ble Justice Kanwaljit Singh Ahluwalia by the order of His Lordship on 25.09.2012 in CRR No. 3605 of 2007 (In Re : Sukhendu Das) to communicate to all Judicial Officers working under your administrative control that the Judicial Officers will not adjourn any matter simply because connected petition is pending before the Hon'ble High Court, unless and until stay order is granted by the Hon'ble High Court.

Accordingly, I am directed to request you to circulate the order of His Lordship Hon'ble Justice Kanwaljit Singh Ahluwalia to all Judicial Officers working under your administrative control for favour of information and necessary action.

Sub: Direct filing of Matrimonial Suits and Motor Accident Claim Cases in the Subordinate Judiciary of West Bengal.

Sir,

In view of the creation of new Courts in the Cadre of District Judge (Entry Level) as Additional District & Sessions Judge either by abolishing the existing Fast Track Courts or by augmentation of the Courts strength in the Cadre, I am directed to re-circulate the direction of the Hon'ble Court as contained in the resolution of the meeting of the Administrative Committee of this Hon'ble Court dated 09.06.1999 & 11.05.2011 duly communicated under Court's letter No. 2393(6)-A dated 08.06.2011. The relevant text of the Resolution of Meeting of the Administrative Committee is reproduced hereinbelow towards necessary clarification and guidance of the matter for sorting out confusion and controversy that has reported by cropped up in some Judgeships regarding direct filing of Matrimonial Suits and Motor Accident Cases in the Courts of Additional District & Sessions Judge in the Sub-divisions under different Districts.

"..... Therefore, it is made clear that in all Districts of the State of West Bengal having Additional District & Sessions Judge in sub-divisions, filing of matrimonial suits and motor accident claims cases shall be allowed, for which the respective District Judges should make necessary provision. It is further made clear that the Resolution of the Administrative Committee June 9, 1999, does not prohibit filing of such applications and suits; on the other hand, it clearly records that Additional District & Sessions Judges located at the sub-divisional headquarters shall have the requisite power of accepting the filing of all appeals, applications etc., which includes matrimonial suits and motor accident claims cases. The only prohibition is in respect of applications and suits which are required to be filed before the District Judge under any statute, to mean, where the statute specifically provides that such applications/ suits will be decided by the District Judges as persona designata".

THIS is for your information and causing further necessary action at your end.
