Sub: New policy of broadband connections under e-courts project

Sir,

I am directed to communicate to you the following new policy of providing broadband connections and continuation of broadband connections under e-courts project.

2) Continuation of Broadband connections under e-courts project: The broadband connections provided to the court complex under Business 1200 plan and to the residence to the Judicial Officers under Home-UL 900 plan will continue even after expiry of two years from the date of commissioning broadband connections. The Area Manager of Calcutta Telephones and the General Manager or Deputy General Manager of West Bengal Telecom Circle have already been intimated in this regard by the Nodal Officers of BSNL under e-courts project.

3) New broadband connections under e-courts project: The proposal of providing new broadband connections under West Bengal Telecom Circle is to be given to the Deputy General Manager (EB) ,West Bengal Telecom Circle by the Central Project Co-ordinator of the Calcutta High Court, instead of moving the proposal directly to the officer of BSNL at the district level. Similarly, the proposal of providing new broadband connections within Calcutta Telephone Circle is to be given to the General Manager (EB), Calcutta Telephones by the Central Project Co-ordinator, High Court. The newly recruited Judicial Officer willing to get broadband connection after joining in the service may furnish his name, designation, residential postal address and BSNL land line number in his name to the High Court through the District Judge, without approaching directly to the General Manager (EB), Calcutta Telephones or the General Manager or Deputy General Manager (EB), West Bengal Telecom Circle for broadband connections under e-courts project.

4) Remedy for claim of broadband charge along with telephone bill by BSNL: The Judicial Officers within West Bengal Telecom Circle from whom BSNL has claimed broadband charge along with telephone bill may approach the General Manager or the Deputy General Manager of BSNL of that area for issuance of revised telephone bill after deduction of broadband charge within West Bengal Telecom Circle, failing which they

may approach to the office of the Central Project Co-ordinator, who will take up the issue with the Deputy General Manager or General Manager of West Bengal Telecom Circle for issuance of revised bill without disconnection of existing telephone line or to restore the telephone line, if already disconnected.

The Judicial Officers within Calcutta Telephone Circle from whom BSNL has claimed broadband charge along with telephone bill may approach the General Manager (EB), Calcutta Telephones of BSNL for issuance of revised telephone bill after deduction of broadband charge, failing which they may approach to the office of the Central Project Co-ordinator, who will take up the issue with the Deputy General Manager (EB) for issuance of revised bill without disconnection of existing telephone line or to restore the telephone line, if already disconnected.

5) Disconnection of broadband on retirement or resignation of Judicial

Officers: The Judicial Officers retiring from service or tendering resignation from service will give intimation about the date of retirement of resignation to the High Court at the time of return of laptop and printer. The Central Project Co-ordinator will give intimation to the General Manager (EB), Calcutta Telephones and the Deputy General Manager (EB), West Bengal Telecom Circle for disconnection of broadband on retirement or resignation of the Judicial Officers having broadband connections under e-courts project within the area of Calcutta Telephone Circle and West Bengal Telecom Circle respectively. The BSNL officers will ascertain the willingness of the concerned the Judicial Officer to continue the broadband connection in his personal capacity by migrating to any of the existing Home Plan by submitting a fresh application after retirement or resignation before making disconnection of the broadband provided under e-courts project.

6) Procedure of providing broadband connections on transfer of Judicial

Officers: It is resolved that the Judicial Officer on transfer from one station to another station necessitating change of residence will physically surrender his broad band modem in the office of the District Judge with official intimation to the Area Manager or General Manager or Deputy General Manager in charge of the respective location of broadband connection, as the case may be. The Judicial Officer surrendering modem in the previous station will collect the broadband modem from the office of the District Judge of the new

station where he will join his new assignment and give intimation to the Area Manager, or General Manager or Deputy General Manager in charge of the locality of the Judicial Officer at the new place of posting for providing broadband connection after furnishing his name, designation, postal address of the residence and BSNL landline number. The District Judge or the Nodal Officer of the District will maintain one register showing name and designation of the Judicial Officer surrendering modem, and name and designation of the Judicial Officer to whom broadband modem is issued after joining on transfer. The Judicial Officers working on deputation or special assignment will surrender their broadband modems to the office of the Central Project Co-ordinator of the High Court with intimation to the Area Manager of Calcutta Telephones and the new officer joining on deputation or special assignment will collect the broadband modem from the High Court and intimate the concerned Area Manager for commissioning broadband connections after furnishing all particulars like name, designation, residential postal address and BSNL landline number.

The Judicial Officer having no previous broadband connections joining new place of posting on transfer will furnish his name, designation, postal address and BSNL landline number to the office of the Central Project Co-ordinator of the High Court through the District Judge with specific undertaking that no previous broadband connection was commissioned in his name under e-courts project. The Central Project Coordinator will take up these cases with the General Manager (EB), Calcutta Telephone Circle and the Deputy General Manager (EB), West Bengal Telecom Circle for providing broadband connections treating the same as new connection for submission of statement to the High Court by the BSNL authority.

Accordingly, I am directed to request you to circulate the new policy of providing broadband connections and continuation of broadband connections under e-courts project to all Judicial Officers working under your administrative control. I am also directed to request you to take the assistance of System Officer for providing information about broadband to the High Court through e-mail.


